Notes from Conference Call

1. Roll Call of CEPDs. (See attached)

2. OCTE Update

- **March 26th Data-Pull Deadline.** The last data-pull for NOCTI and Oklahoma Career Tech will be done on March 26, 2013. All students enrolled in the following programs must be entered in CTEIS *before March 26th* in order to be included in the data-pull that will be submitted to NOTCI and Oklahoma:

- 26.0102 – Biotechnology Medical Services
- *43.0100 – Public Safety/Protective Services
- 51.0000 – Therapeutic Services
- 51.0707 – Health Informatics
- 51.1000 – Diagnostic Services
- *52.0299 – Business Administration Management
- *52.0800 – Finance & Financial Management

***Important Note:** *Districts offering these programs must have all their buildings registered with NOCTI prior to the data pull.*

This data-pull will allow NOCTI and Oklahoma to match the Technical Skills Assessment Test scores with the correct CTE students, using the UIC, first name, last name, date of birth, and gender.

Note: The 4483 does not have to be validated in order for the student records to be included in the data-pull. Students just need to be *enrolled* in CTEIS in order to be included in the data-pull.

- **Clarification of UIC and MSDS Record Checks.** The UIC Record Check and the MSDS Record Check are two separate processes, each with a different purpose.

UIC Record Check. The purpose of the UIC record check is to compare all UICs entered in CTEIS against CEPI's ***UIC Master*** to make certain that each student in CTEIS has a ***valid*** UIC/First Name/Last Name/Gender/Date of Birth combination. The UIC record check reviews all newly-imported UIC's overnight.

MSDS Record Check. The purpose of the MSDS import is to populate student demographics in CTEIS, using data from the MSDS records. The MSDS data are matched to the CTEIS student record, using the UIC. The MSDS import is done in batches – and it only updates students that are enrolled in CTEIS. MSDS errors show up on the CTEIS 4483 report, when the validation is run. The MSDS update only occurs if something in the student's CTEIS record changes. (Note: Every student's ***complete record*** is matched only two or three times per year.)

We encourage CTEIS users to check the ***Bad UIC List by Building*** and the ***UIC's with No Current MSDS Record Report*** in order to ensure that your students have a valid UIC, and updated MSDS data. These two reports can be found on the CTEIS website by selecting ***Reports*** → ***Building Reports*** → located under the heading: ***Student Reports***.

Important Note: *Students that do NOT have a current MSDS record are NOT eligible for Section 61a1, Added Cost funds, and are not retained in the CTEIS system.*

- **Program Completer Definition.** For clarification purposes, to be considered a *program completer*, the student must complete (with a grade of 2.0 or better) course-sections which cover *all 12 segments* of a program, **and** (if applicable), take the technical skills assessment test associated with that program. (*Note:* Students are not required to *pass* the technical skills assessment test in order to be considered completers - - they just have to *take* the test.)
- **Segment Q Confusion.** Segment Q has been designated for reporting advanced program content – content advanced beyond (*not covered by*) any of the 12 segments required for program completion. There still seems to be some confusion concerning Segment Q, and the requirements that must be met before a student is eligible to be enrolled in Segment Q.

In order for a student to be eligible to enroll in Segment Q, they must *first* meet the definition of a *Program Completer* (noted above) *before* they enroll in Segment Q. The student should *not* be concurrently enrolled in Segment Q and any of the 12 segments required for program completion. It is only *after* the student has completed (and passed) all 12 segments of a program, and taken the assessment test (if applicable), that they are eligible to enroll in Segment Q.

If a student does *not* pass (with 2.0 or better) the course-sections which cover all 12 segments of a program, that student must go back and complete (with a passing score) the required content, before they are eligible to enroll in Segment Q.

- **Technical Skills Assessment Policies.** There were a number of questions concerning the Technical Skills Assessments tests, and parameters for re-taking the test. OCTE has developed a Technical Skills Assessment Policy document in response to these questions, that can be found on the OCTE website – <http://www.michigan.gov/octe>.

3. PTD Update

- **Follow-Up.** Follow-up training has been completed for the year. If you have questions concerning the Follow-up Surveys, please contact the CTEIS help desk for assistance at 1-800-203-0614 (ext. 127), or you can email the help desk at CTEIS.help@ptdtechnology.com.
- **Common Reasons Why Students May Not Appear on Follow-up List.** If students don't appear on the Follow-Up list (that you expected to see), there are a number of circumstances that may have caused this to occur. Following, are two of the most common problems:
 - ◆ Student's Exit Status is inaccurate in CTEIS or MSDS – compare the *Exit Status* in CTEIS with MSDS to make sure they match.
 - ◆ Student does not meet all the criteria necessary to be considered a *program completer* – check the student's program history in CTEIS to verify that they have completed all 12 segments of the program (with a passing grade of 2.0 for *each segment*).

If you have questions concerning students that do not appear on the Follow-Up List, please contact the CTEIS help desk for assistance.

4. Issues from CTEIS Users

- **New/Experienced Users Dialogue.** In response to several requests from the field, we are trying something new. At the conclusion of each CTEIS User Group Conference call, we will keep the call open to provide an opportunity for dialogue between new CTEIS users and more seasoned users.

We are hoping that this will provide added support to new CTEIS users, as they navigate the nuances of CTEIS reporting – give them a practical sense of reporting priorities; help them become more familiar with reporting screens and practices; and possibly help them avoid pitfalls from a CTEIS user's standpoint. This would also provide OCTE an increased awareness of reporting concerns, as well as potential opportunities for improvement.

- **As Always...** We encourage the CTEIS User Group, as representatives for their CEPD, to share information gleaned from these conference calls with other CTEIS Users in your respective CEPDs. Forwarding the Notes and information received from the conference calls is a good way to keep everyone informed, and may help to reduce problems, concerns, and errors.
